# FLAVON MAX CONSUMER CLUB MEMBERSHIP AGREEMENT ("For AutoShip Order Form")

This contract has been established between Flavon Group Kft. located at H-4033 Debrecen Veres Péter u. 19., HUNGARY (registry number: 09-09-011706, tax number: HU 13526456, represented by: László Gaál) – hereafter referred to as 'FLAVON GROUP' – as the first party, and the procurer having signed the attached AutoShip order form – hereafter referred to as the 'CLUB MEMBER'

- The Flavon Max Consumer Club is a buyers' club program created by Flavon Group, which sells commercially-unavailable special products to its members for personal use.
- Acceptance of the contract authorises the Club Member to buy products and to receive compensation offered by the marketing plan. In the case of individual applicants, only natural persons of full age may apply to be members of this Consumer Club.
- The Club Member acknowledges that he/she is a person independent from Flavon Group, and is not an employee, agent or representative of Flavon Group. The Club Member is not entitled to undertake liabilities on behalf of Flavon Group.
- The Member acknowledges that no guarantees were made to him/her with respect to income, success or profit. If the Member is entitled to a commission, then his/her verifiable business enterprise indicated in the present Agreement (in which the Member has the right to represent) shall invoice the amount of such commission to Flavon Group.
- The Member shall be responsible for compliance with all provisions of law relevant to his/her business enterprise.
- The Member agrees to refrain from using names, trademarks or other materials protected by copyrights without the prior written consent of the company. The Club Member may not use the company's Flavon max network, its club membership list or any other confidential information for the distribution or sales of products or services other than goods distributed by Flavon Group. The Club Member acknowledges that disclosure of any confidential information to a third party, even to a relative of the club member, (in the event that he/she is not a member of the network), shall constitute a breach of the contract.
- A Member damaging the business reputation of the Consumer Club program shall be deemed as having committed a breach of contract.
- The Member may only use publications, information leaflets, brochures, books, cassettes, flyers and internet websites published by Flavon Group, and shall not modify them or use them in a manner or for a purpose different from the originally intended. Own materials drawn up or advertisements to be published must be submitted to Flavon Group for approval in all cases. It is forbidden to make statements deceiving the consumers and confirming healing or preventive effects of the products. It is permitted to give account of one's personal experience related to the product. It is forbidden to make statements to the press regarding the products or the network in any type of media (traditional, electronic, etc.), and is allowed only with the preliminary written approval of the manager of Flavon Group. The Member shall be liable for all consequences any unfair market practices pursued by him/her. Any liability of Flavon Group with respect to such practices is hereby excluded.
- Any violation of the Member's obligations under the present contract or the Organisational and Operational Regulations of the Flavon max Consumer Club shall result in termination of the membership, as well as an obligation to pay damages and contractual penalty. The amount of the contractual penalty shall be ten times the commission for the month prior to the breach of obligation. The injured party may also demand damages in excess of the amount of the contractual penalty.
- The Club Member acknowledges that Flavon Group may modify the contract or the marketing plan without notification. The modification comes into effect when it is announced in the company's publications or on its homepage: [www.flavonmax.com](http://www.flavonmax.com).
- The Parties agree that Annex 1 to this deed is a document entitled, "Organisational and Operational Regulations of the Flavon max Consumer Club", and that the contracting party has studied, understood and accepted its contents. Flavon Group reserves the right to approve or reject any contract.
- Flavon Group undertakes liability for the shipment of 3 cartons of Flavon max and/or Favon max Plus+ and/or Flavon Kids products every three months in the given period of month. If the shipment of the products cannot be fulfilled for any reasons, the Club Member may modify his/her order. In case it is inconvenient for the Club Member and/or he/she would not like to modify the order, the products shall not be shipped and the bank card will not be charged.
- Products are shipped to the Club Member only after the completion of the timely remittance.
- Flavon Group is not liable for any delay, damage occurring during shipment and problems caused by financial institutions.
- The Club Member can cancel or modify (e.g. composition of package, address, etc.) an AutoShip Order by notifying Flavon Group by the 10th of the previous month the latest, prior to the next shipping due. The Club Member must fill in the required form including his/her AutoShip code, of which he/she shall be notified in the first shipment.
- The Club Member undertakes liability for the authenticity of his/her personal data provided on the AutoShip Order Form. Should there be any change in these details (with special emphasis on payment details), the Club Member must notify Flavon Group in 8 working days.
- Flavon Group shall charge the Club Member's bank card in every three months with the amount designated in the effective AutoShip Order Form. In the event that the Club Member is eligible for a purchase discount, Flavon Group will automatically charge the Club Member's card with the amount decreased with the purchase discount each quarter.
- The bank card specified in the AutoShip Order Form must be valid for at least four more months counted from the date when this contract is signed.
- If Flavon Group, for any external reasons (insufficient credit, transaction declined, incorrect card details, etc.), is unable to charge the given bank card with the correct amount, the Club Member shall be notified via phone or e-mail. Flavon Group is entitled to make another attempt to charge the card in the following five days after the notification. If the transaction is declined again, the given AutoShip agreement will be terminated immediately and automatically, and the product shall not be shipped to the Club Member.
- Flavon Group reserves the right of price change but shall notify the Club Member beforehand.
- The Club Member is free to purchase products from Flavon Group in other ways after signing or terminating this contract.
- This contract can be terminated by any of the two Parties without prejudice or penalty after fulfilling the current liabilities.
- An AutoShip Order Form has to be submitted only once, there is no need for quarterly resubmission.
- Flavon Group reserves the right to decline any AutoShip Order Form filled in insufficiently or erroneously.
- This contract takes effect on an on-going basis, and terminates as soon as Flavon Group is notified by the Club Member in writing via an AutoShip Order Cancellation Form.
- Confirmation of the AutoShip order cancellation will be sent to the Club Member. The elite club member closest to the Club Member in the sponsor-line shall also be notified of the cancellation.
- The Club Member cannot use the cartons purchased in the frame of the AutoShip program to build a consumer network, it shall be registered as a personal purchase.
- The Parties hereby submit, depending on the value of the litigation, to the exclusive jurisdiction of the Municipal Court of Debrecen or the Hajdú-Bihar County Court, to settle any disputes arising from or in connection with the present contract.
- The Club member hereby confirms that his/her entry to the AutoShip program is fully voluntary.

The Parties hereby declare that they have studied, understood and accepted the present contract, which reflects their contractual will in all respects. The Member declares that he/she had an opportunity to clarify any questions with his/her sponsor. The present contract shall be deemed to have come into effect when accepted by Flavon Group and an identification number was issued to the Member.

I hereby consent that my personal data may be stored, handled and forwarded by the employees of Flavon Group Kft. for the purposes of use in the business activities, keeping records of commissions, bonuses and rebates, as well as for maintaining contact with me.
