

## PROMOTIONAL CONTEST RULES – FLAVON AR

### The Official Promotional Contest Rules by Flavon Group Kft.

**1. The Organizer of the Online Promotional Contest is Flavon Group Kft.**

address: 4033 Debrecen, Veres Péter utca 19, further referred to as „Organizer” is organizing a promotional contest - further referred to as „Contest” - among the users of the application named FLAVON AR.

**2. Entrants and eligibility:**

Any natural person over the age of 18, who downloads the FLAVON AR application, registers and enters the Contest, is eligible to enter the Contest regardless of their nationality or place of residence.

The employees and immediate family members of the Organizer are ineligible to participate in the Contest.

**3. Participation in the Contest:**

Anyone who downloads FLAVON AR application is eligible to enter the Contest. The goal of the Contest is to collect as many points as possible. There are no limitations as to time or frequency for anyone entering the Contest.

There are daily and monthly winners.

**3.1. The daily winner is the Entrant who has collected the most points that particular day. The current daily standing is displayed after each game. The nickname of the Participant with the most points on the day is shown.**

The daily winner has to be a different participant each day. If a participant has become the daily winner and any day later in the same month the same participant earns the most points, the next participant in the daily standing will be the daily winner. If the next participant in the ranking has already been announced the daily winner any time that month, then the title goes to the next person in the daily standing and so on.

The daily winners will be notified within 5 working days. All participants are requested to check their SPAM/JUNK folders too. If the daily winner fails to get back to Flavon within 5 working days from the receipt of the prize notification, the prize will be forfeited.

The daily scores will be restored to zero at midnight each day.

The daily winner is awarded a jar of RUBY BY FLAVON.

- 3.2. The monthly winner is the participant with the most points in that particular month regardless of the points he/she earned as a daily winner. The monthly ranking gets deleted at the end of each month, and the next ranking starts the following month. A monthly winner cannot become a monthly winner again later.

The monthly winner will receive a prize which is 1 carton of RUBY BY FLAVON product.

The monthly winner will be notified within five days from the last day of the given month. All participants are requested to check their SPAM/JUNK folders too. If the monthly winner fails to get back to Flavon within 5 working days from the receipt of the prize notification, the prize will be forfeited.

#### **4. The length of the Contest:**

The Contest lasts as long as FLAVON determines to run it.

The winner is obliged to cooperate with the Organizer to ensure that the prize is delivered within one month from the receipt of the notification from Flavon. If the Winner fails to comply with this obligation to cooperate and the timely delivery of the prize is thus prevented, the Organizer shall not be held liable for this circumstance. The Organizer can provide the possibility of the collection of the prize within this period, which period cannot be extended. Failure to meet the deadline will result in losing eligibility for the prize. The prizes will be delivered by the Organizer. The prizes will be delivered to the address provided by the winner, if delivery to the given address is not disrupted in any way. Such delivery disruption might be caused by a foreign country address where Flavon does not deliver, or an address which is incorrect/not accessible.

#### **6. Data Protection Policy:**

Data obtained through the registration are confidential and used by the Organizer during data processing. Participants entering the Contest automatically agree to abide by the official rules of the Contest along with the Data Protection Policy and they acknowledge that

- a) Provision of data is voluntary, personal data are processed based on the voluntary consent given at the time of the data provision. Such consent to process personal data is automatically given by entering the Contest, that is by completing the registration.

- b) Personal data of the Winners may be made public by the Organizer. Such publication is limited to their names and the administrative name of the municipality where they reside.

Personal Data shall not be disclosed to any third party without the prior information and consent of the data owner (Participant) except for cases defined by the law.

The Organizer guarantees that data processing is carried out in compliance with all applicable laws and regulations. The rights related to data management and the rules of legal remedies are set out in Act CXII of 2011 on the Right to Informational Self-Determination and Freedom of Information (hereinafter: Info. Act), according to which the Participant may request the alteration, erasure of his/her personal data, and also information regarding the processing of his/her personal data, and may request judicial remedy. Participants wishing to have their data erased or altered in the database may request this without justification and without restriction, and free of charge by contacting:

The Organizer will treat and process the personal data of the winner as confidential information in compliance with Act CXII of 2011 on the Right to Informational Self-Determination and Freedom of Information and with Act CXIX of 1995. Personal data will be used solely for the purpose of the Contest.

#### **7. Rights held by the Organizer:**

The Organizer shall not be liable for, and excludes all claims for any costs and expenses, damages and losses arising out of or in connection with any defects, malfunctions of the game. The Organizer reserves the right to change the terms and conditions of the Contest following the notification of the participants. By participating, participants automatically accept these rules.

#### **8. Other provisions:**

The prize may not be exchanged for cash or other property or rights.

The validity of the email address used by the Participant in the Contest is the responsibility of the Participant, and the Organizer shall not be liable for any problems arising from this. Any violation of the Contest Rules, even after the collection of the prize, may result in exclusion from the Contest and possible legal action. The Participant takes full responsibility for any damage caused to the Organizer by a breach of the rules of the Contest. The decision of the Organizer on the issue of disqualification is final and cannot be contested.

The Organizer has the right to exclude any registered Participant from the Contest to whom the prize cannot be delivered due to the provision of untrue or incorrect personal details. In issues concerning the validity of the submitted registrations or in any other disputes arising the decision of the Organizer shall prevail.

The Organizer disclaims any liability for any malfunction of the Application and the game server due to causes beyond its control, but will take all necessary measures to promptly identify and eliminate the causes of the malfunction.

The Organizer shall not be liable for any expenses, damages or losses arising out of or in connection with any defects, malfunctions of the game (e.g. loss of registration details) or any delays occurring in the course of the Contest; excluding liability for losses and damages caused by conscious, voluntary acts or gross negligence, incurred by the Participant.

The Organizer shall not be liable for the availability and functioning of the IT equipment or the actions of any third parties. The Organizer shall not be liable for the malfunction of the online interfaces due to causes beyond its control, including in particular the malfunction or inaccessibility of the server operating the online interface, the lack of internet connection, and the operative malfunctions of the backbone network or the failure to connect to the internet interface or to part of it. All email messages sent by the mail server shall be regarded delivered. The Organizer reserves the right to exclude any Participant from the Contest who violates the rules of the Contest, or who would become a winner through fraudulent means.

The Organizer reserves the right to change the rules of the Contest if deemed required. Such changes will be communicated to the Participants at [www.flavonmax.com](http://www.flavonmax.com). It is the registered Participants' responsibility to check the website for information regularly. The decisions of the Organizer concerning the Contest are final and binding in all respects, and cannot be contested.
