The organizers of the event will handle the personal details of the participants at the event as follows:

1./ We would like to inform you that the organizers provide interpreter devices for the participants at the event which devices are owned by the company providing technical support; the organizers must settle accounts for them once the event has ended. In order to use the interpreter devices, you have to provide a photo ID or leave a deposit of 10.000, - HUF.

Providing a photo ID is based on voluntary contribution in every case, if the participant does not wish to provide it then there is an option to leave a deposit of 10.000, - HUF in order to use the interpreter device.

We will hand back the photo ID to its owner at the same time when the interpreter device is returned. Only those employees of the event organizers can see and take the ID cards who are present at the site of the interpreter devices. The photo ID cards will not be handed over to any third party and no photo copy of those ID cards will be made.

2./ We would like to also inform you that the event organizers as Data Managers will make videos and photographs on which the visitors of the event could be recognized. The photographs will be published by the event organizers during their marketing activities on their website (www.flavonmax.com) and on their social media (Facebook, YouTube, Instagram) platforms.
